

An open letter on Canada's plan to reduce greenhouse gas emissions from the aviation sector

Dear Ministers,

We are deeply concerned about the continued rise of greenhouse gas emissions from Canada's aviation sector.

According to the [latest report](#) from Transport Canada, GHG emissions from Canadian airlines increased by 74% between 2005 and 2019, to over 22 million tonnes annually, the equivalent of emissions from almost five million passenger vehicles.

This rise in aviation emissions is incompatible with Canada's commitment to reduce total GHG emissions by 40-45% by 2030.

We are pleased that Canada is developing a new Action Plan to reduce aviation GHG emissions, for release by early fall.

We are very concerned however, to hear that Transport Canada is consulting with the aviation industry on the plan, but has no intention to consult the public and other stakeholders on its content.

Without strong public consultation there is a significant risk that the new plan, like the previous [2012 Plan](#), will fail to reduce aviation emissions (aviation emissions have risen by over 35% since the 2012 Plan was released).

Canada is lagging behind other countries - and its own airlines - by failing to commit to reduce aviation emissions in the near term.

Denmark, for example, has committed to make all domestic flights fossil-fuel free by 2030. And Air Canada has committed to reduce GHG emissions from flights by 20% over the same period.

For too long, Canada's aviation industry has been allowed to increase its levels of destructive climate pollution.

We urge you to take immediate action to ensure: a) that public and non-industry stakeholders are consulted on Canada's new aviation emission reduction plan before it is finalized and released, and b) that the new plan contain strong and binding emission reduction targets of at least 30% (from 2019 levels) by 2030.

We are counting on you to ensure that the aviation sector, like all other sectors, does its fair share to reduce harmful GHG emissions and protect a liveable future for all.
